Please be advised the Oriole Golf & Tennis Club Condominium Two Association, Inc. (the "Association"), represented it would terminate all action for removal of Maxie. The Association's attorney advised it would, first, contact your health care providers to determine the validity of medical documentation if it sought removal of Maxie in the future.

Although the Association indicated it would no longer attempt to enforce its no pets provision against you, please be advised you have the right to file a complaint for housing discrimination. Should you wish to file a complaint, you may do so with the Florida Commission on Human Relations ("FCHR") and/or the U.S. Department of Housing and Urban Development ("HUD").
